We feel that there is a gap and at the same time, a dire need to bring in process workflows to make the program more effective and rewarding.



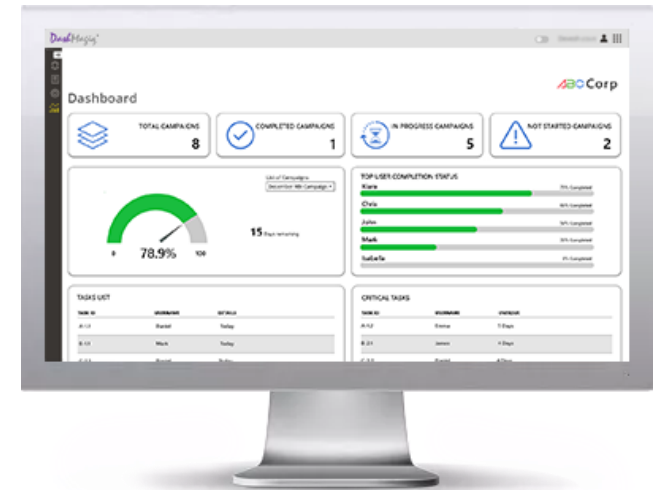
